Staff advised that while DAAC's input is valued, long-term energy storage solutions are an important part of the sustainability of a modern energy grid and suggested that EAs be allowed to inform the siting of such facilities, rather than a blanket policy to prohibit them on agricultural lands.

He advised that when the new Official Plan is approved, it would be many more years before any development in the new growth areas (9,100 acres) is expected to take place. He further advised that the status of the new Official Plan will not have an impact on the 2024 budget.

2023 North Durham Building Business Forum

Recommendation:

Report:

1. Purpose

1.1 The purpose of this report is to provide an overview of the North Durham Building Business Forum event that was held on November 14, 2023.

2. Background

- 2.1 The Agriculture and Rural Economic Development Section of the Economic Development and Tourism Division (Invest Durham) delivers economic development programming and initiatives in the Townships of Brock, Scugog and Uxbridge (north Durham).
- 2.2 This team led the planning and implementation of the 2023 North Durham Building Business Forum to bring together entrepreneurs and small business owners from across north Durham, share useful information and knowledge to help them grow, and expand the reach of Durham Region business support organizations.

3. Previous Reports and Decisions

- 3.1 The 2023-2027 Growing North Durham: Rural Economic Development Action Plan was received by the Planning and Economic Development Committee on February 7, 2023 (Report 2023-EDT-2).
- 3.2 The re-introduction and hosting of the North Durham Building Business Forum was a key action identified under the "Support Entrepreneurship" goal of the Growing North Durham Plan.

4. North Durham Building Business Forum

- 4.1 The 2023 North Durham Building Business Forum was held on November 14, 2023 from 10:00 a.m. 2:00 p.m. during 'Do It In Durham Entrepreneurship Week' at Trail Hub in the Township of Uxbridge.
- 4.2 The free event welcomed more than 100 attendees from a wide range of commercial and home-based businesses, local business support organizations, and north Durham municipalities (staff and members of Council).
- 4.3 The primary goals of the event were to expand the reach of local and regional business support organizations, build knowledge and capacity amongst north Durham entrepreneurs by organizing useful and informative speaking sessions, and to facilitate networking opportunities for attendees.
- 4.4 The following elements were built into the event to help achieve the desired goals:
 - a. **Business Support Organization Tradeshow:** More than 15 business support organizations with a presence in Durham Region set up information booths at the event, allowing attendees to learn about the services they offer, ask questions, and connect with staff.
 - b. **Relevant and Informative Speaking Sessions:** A steering committee consisting of north Durham business leaders and municipal/regional staff identified topics of interest and potential speakers. Sessions included:
 - Business Resiliency Fireside Chat Joanne Richter of Second Wedge Brewing Co.
 - Social Media for Small Business Panel discussion featuring north Durham entrepreneurs
 - Entrepreneur Spotlight Zechariah Thomas of SWIFT Hockey

- What Employees Want: Attracting, Engaging, and Retaining Talent in a Changing World – Amy Davies
- c. **Networking Opportunities:** Attendees were given the opportunity to network with other entrepreneurs, small business owners and support staff at multiple points throughout the event.
- 4.5 Following the event, a post event survey was circulated to attendees. Key highlights include:
 - a. 96% of respondents said that the event met or exceeded expectations.
 - b. 70% of respondents were 'very satisfied' with the format of the event. An additional 24% stated that they were 'satisfied' with the format.
 - c. 79% of respondents said that they would 'definitely attend' another North Durham Building Business Forum. An additional 18% said they would likely attend another.

5. Relationship to Strategic Plan

- 5.1 This report aligns with/addresses the following strategic goals and priorities in the Durham Region Strategic Plan:
 - a. Economic Prosperity: To build a strong and resilient economy that maximizes opportunities for business and employment growth, innovation and partnership.
 - 3.1 Position Durham Region as the location of choice for business
 - 3.2 Leverage Durham's prime geography, social infrastructure, and strong partnerships to foster economic growth.

6. Conclusion

- 6.1 The 2023 North Durham Building Forum was successful in bringing together entrepreneurs from across north Durham to share knowledge, ideas, resources and information.
- 6.2 To continue delivering on the goals of the Growing North Durham Plan, the Agriculture and Rural Economic Development Section plans to host another business forum event in north Durham in 2024. Staff will work with partners to determine whether the format, target audience, size and scale of the event should be adjusted.
- 6.3 This report will be circulated to the Townships of Brock, Scugog and Uxbridge.

Recommendation:

Report:

1. Purpose

- 1.1 The purpose of this report is to provide an annual report on the implementation of the Growing North Durham: Rural Economic Development Action Plan.
- 1.2 The report will be accompanied by a staff presentation from Stacey Jibb, Manager of Agriculture and Rural Economic Development and Glen Macfarlane, Economic Development Specialist.

2. Background

2.1 The Growing North Durham Plan was endorsed by Regional Council as well as the Councils in the Townships of Scugog, Uxbridge and Brock in early 2023. It sets out goals and actions to support economic growth across north Durham to 2027.

2.2 The Growing North Durham Plan is a collaborative north Durham-wide approach to economic development, where resources are shared across the three Townships to advance common interests for economic development and tourism.

3. Previous Reports and Decisions

3.1 The 2023-2027 Growing North Durham: Rural Economic Development Action Plan was received by Planning and Economic Development Committee on February 7, 2023 (Report 2023-EDT-2).

4. Implementation Update

- 4.1 The delivery of economic development programming in north Durham relies on collaboration between Durham Region, the Townships of Scugog, Uxbridge and Brock, and various business support organizations such as the Brock Board of Trade, Scugog Chamber of Commerce, Uxbridge Chamber of Commerce, Business Improvement Associations (BIAs), and more.
- 4.2 This collaborative approach encourages communities to take part in identifying opportunities and solutions to economic challenges and has been integral in the implementation of the Growth North Durham Plan so far.
- 4.3 The Growing North Durham Plan is structured under three pillars: People, Places and Prosperity. Each pillar contains goal areas and actions that support a community-driven approach to economic development. Identified below are some of the key activities that are either underway or were completed within each pillar over the course of the past year:
 - a. **People**: This pillar recognizes the strong correlation between human capital and economic growth.
 - Hosted the North Durham Building Business Forum on November 14, 2023.
 - Plans are underway to complete a workforce planning study to help identify gaps in workforce data and skills in north Durham.
 - Throughout 2023, continued to share relevant information with entrepreneurs and small business owners through a bi-monthly enewsletter, Invest Durham social channels, and one-on-one meetings.
 - North Durham innovation success stories are featured through Invest Durham social channels and other marketing.

- In partnership with the Business Advisory Centre Durham (BACD), supported the delivery of Digital Mainstreet programming which aims to enhance digital literacy skills. A particular focus was placed on the Township of Brock given they do not have a BIA.
- Plans are underway to partner with Durham College and the National Research Council/Industrial Research Assistance Program to connect information and communications technology companies with agri-food operators in north Durham to support innovation in the agri-food sector.
- b. **Places**: This pillar highlights and strengthens north Durham's unique qualities of place that stimulate meaningful connections with the community.
 - Several initiatives and campaigns have been delivered over the last year with strong north Durham content or focus. These include:
 - (i) Collision Conference 2023 (Region Economic Development staff attended on behalf of north Durham).
 - (ii) Shop Where You Live
 - (iii) Gather at the Farm
 - Ongoing support for municipal efforts to undertake Red Welcome Wagon visits, a Scugog Economic Development Advisory Committee-led initiative. Regional Economic Development staff also attend and support business openings, when possible, in Uxbridge and Brock.
 - North Durham sites were featured as part of Invest Durham's signature sites project and led to a significant investment opportunity with the <u>Tessera Group in the Port Perry Employment Area</u>.
 - Working closely with Township staff, Rural Economic Development (RED) grants were secured in 2023 for Uxbridge and Brock for downtown revitalization and updating Community Improvement Plans.
 - Ongoing support and representation on the Uxbridge Downtown Revitalization Advisory Committee.
- c. **Prosperity**: The prosperity pillar is about business retention and making informed decisions to encourage and enable economic growth.
 - Regional staff continue to work closely with the Township of Scugog to implement the Scugog Business Program; this work is expected to continue into Fall of 2024 and was the result of a successful RED grant application.

- Using the Scugog Business Program as a model, Regional staff will be begin development of a more standardized approach to business visitations across north Durham to effectively deliver business retention programming.
- Regional Economic Development staff, in coordination with Development Services staff from across north Durham, respond to investment inquiries on an ongoing basis. Investment inquiries are generated through the Region of Durham's Business Development and Investment Team who undertake investment attraction work on behalf of all Durham municipalities.
- Online business toolkits were developed and launched in <u>Scugog</u>, <u>Uxbridge</u> and <u>Brock</u> throughout 2023. The toolkits provide a one-stopshop of information and resources for new and existing businesses as well as those looking to grow their business in north Durham.
- Led by Durham Region Economic Development Staff, the Townships of Scugog and Uxbridge supported an application from South Lake Community Futures Development Corporation (SLCFDC) requesting approval from FedDev Ontario to expand the SLCFDC catchment area. If approved, this expansion would allow businesses across north Durham to access new streams of Federal funding and resources. Businesses and organization located in the Township of Brock are already eligible for funding and support through SLCFDC.

5. Relationship to Strategic Plan

- 5.1 This report aligns with/addresses the following strategic goals and priorities in the Durham region Strategic Plan:
 - a. Economic Prosperity: To build a strong and resilient economy that maximizes opportunities for business and employment growth, innovation and partnership.
 - 3.1 Position Durham Region as the location of choice for business
 - 3.2 Leverage Durham's prime geography, social infrastructure, and strong partnerships to foster economic growth

6. Conclusion

6.1 The Growing North Durham Plan represents an ongoing commitment for a collaborative north Durham-wide approach to the delivery of economic development programming in the Townships of Scugog, Uxbridge and Brock. Updates have been

scheduled and/or delivered to each Council in north Durham to update the Townships on progress implementing the Growing North Durham Plan, and scheduled activities for 2024.

Recommendation:

That the Planning and Economic Development Committee recommends to Regional Council:

- A) That the Durham Region 2023 Ontario Parasport Games Legacy Fund of \$145,579 be distributed as follows:
 - i) Durham Community Foundation "Durham Region Adaptive Sport & Recreation Legacy Fund": \$112,000.
 - ii) Adaptive Sport Festival: \$30,000.
 - iii) Community Tree and Shrub Planting: \$3,579.
- B) That, prior to the distribution of funds to any agency receiving funding from the 2023 Ontario Parasport Games Legacy Fund, the Region enter into an Agreement or Memorandum of Understanding which prescribes appropriate reporting requirements, and which are otherwise in a form satisfactory to the Commissioner of Finance.

Report:

1. Purpose

1.1 At the Planning and Economic Development Committee meeting on June 6, 2023, report 2023-EDT-7 provided highlights of the Durham Region 2023 Ontario Parasport Games and indicated that a subsequent report would provide the financial and economic impact results of the Games. This report summarizes the final financial results of the Games, provides an update on 2019 Games legacy initiatives, and makes recommendations for the distribution of the \$145,579 Games Legacy Fund.

2. Background

- 2.1 From February 3 to 5, 2023, Durham Region welcomed more than 400 athletes, athlete assistants, coaches, managers, officials, and provincial sport organization representatives, as well as hundreds of spectators to the Durham Region 2023 Ontario Parasport Games, building on the momentum from hosting the Games in 2019.
- 2.2 Athletes competed in 11 sports at eight sport venues, throughout five municipalities across the Region. The Games also included four demonstration sports, a new addition to the Games intended to elevate the profile of emerging sports within Durham Region and beyond.
- 2.3 The final report for the Games was submitted to the Ontario Ministry of Tourism, Culture and Sport (MTCS) on November 23, 2023, following the completion of an independent financial review by Deloitte LLP.
- 2.4 The Durham Region 2023 Ontario Parasport Games were a resounding success. The Games received tremendous support throughout planning and execution from the entire regional community in the way of sponsorship, volunteerism, spectators, contracted services, headband knitting, athlete support through the 'Be The Roar' campaign, attendance at special events, and much more.

3. Games Financial and Economic Impact Results

3.1 Sponsorship and fundraising activities for the Games generated nearly \$267,000 (\$179,774 cash and \$87,028 in-kind), demonstrating the overwhelming support of partners from Durham Region and beyond, and surpassing the initial sponsorship target by nearly 165 per cent.

- 3.2 Other sources of financing for the Games included \$135,000 from the Ontario MTCS (\$125,000 hosting grant and \$10,000 legacy fund grant following Regional Council approval of Games Legacy Fund recommendations) and \$99,120 from the Region of Durham (\$40,000 cash and \$59,120 in-kind for internal transportation provided by Durham Region Transit).
- 3.3 The Games surpassed the initial budgeted surplus/legacy target of \$60,230 by approximately 240 per cent, resulting in a Games Legacy Fund of \$145,579.
- 3.4 According to the economic impact assessment completed using the Sport Tourism Canada Sport Tourism Economic Impact Assessment Model (STEAM2.0), the Games generated an estimated \$872,991 in economic activity across the Province, \$702,853 of which occurred in Durham Region.

4. Durham Region 2019 Ontario Parasport Games Legacy Initiatives

- 4.1 The Durham Region 2019 Ontario Parasport Games generated a Legacy Fund of \$111,900. On November 5, 2019, report #2019-EDT-17 identified the initiatives that would receive those funds. Updates on these initiatives are provided below.
 - a. 'Their Opportunity': Since its launch in August 2021, the Parasport Games Legacy Fund Grant, administered by Oshawa-based national children's charity, Their Opportunity, has provided funds for 64 youth to participate in four adaptive or all abilities sport programs in Durham Region. The current balance of the fund is \$19,000. A new, streamlined application process is being launched in January 2024.
 - b. 'Parasport School Grow It Program': Economic Development and Tourism staff established a partnership with Abilities Centre to lead this program to introduce parasports to selected schools in Durham Region, in collaboration with the DASC. Teacher training on boccia and sitting volleyball was delivered to a group of Durham District School Board teachers, but the pandemic impacted the delivery of the full scope of the program. Abilities Centre is currently working on a revised program approach in partnership with the Ontario Physical and Health Education Association, with the goal of completing a pilot with one school by the end of June 2024.
 - c. Parasport Festival: This initiative was put on hold due to pandemic impacts. However, in celebration of the 100-day countdown to the 2023 Games, the Games Organizing Committee hosted school and community try-it sessions featuring three parasports. The legacy funds from the 2023 Games will be added to remaining funds for this item. Together with the Durham Adaptive

- Sport Collective (DASC), community partners, and contracted resources, a fulsome Adaptive Sport Festival will be planned and held in 2024 or 2025. The Festival will provide community members with information on local adaptive sport programs and other resources, and will offer try-it opportunities. An Adaptive Sport Festival will also be planned.
- d. The Town of Whitby's Iroquois Park Sports Centre Arena 3 Sledge Hockey Accessibility Upgrades: In June 2022, modifications were completed to improve accessibility for sledge hockey at Iroquois Park Sports Centre. The upgrades improve the playing experience for sledge hockey players and provide increased opportunities for Durham Region to host sledge hockey events in the future. Modifications included replacing the boards at the players' benches and penalty boxes with clear polycarbonate viewing panels; adding 36-inch-wide gates to the players' benches and penalty boxes; lowering the entrance area to players' benches and penalty boxes; and replacing fixed benches with removable benches.

5. Durham Region 2023 Ontario Parasport Games Legacy Fund Initiatives

- 5.1 Economic Development & Tourism staff updated the criteria established for the distribution of the 2019 Games Legacy Fund, to guide the distribution of the 2023 Games Legacy Fund of \$145,579. The criteria were approved by the Ontario MTCS. Legacy initiatives must support the nurturing and growth of parasport in Durham Region and deliver one or more of the following benefits:
 - a. Increased adaptive sport participation.
 - b. Increased awareness of adaptive sport opportunities.
 - c. Accessibility upgrades that improve the playing experience for athletes of all abilities.
 - d. Increased opportunities for hosting adaptive sport events, i.e., sport tourism benefits.
- 5.2 The majority of the Legacy Fund (\$112,000) is proposed to be directed to the Durham Community Foundation. It is proposed that Durham Region will enter into a partnership with Durham Community Foundation (DCF) to administer a newly established Donor Advised Fund called the "Durham Region Adaptive Sport & Recreation Legacy Fund." The purpose of the Fund will be to support adaptive/parasport activities, programs, and events offered in Durham Region, including but not limited to, competitions such as the Ontario Parasport Games, to grow adaptive sport opportunities and participation. Economic Development and Tourism staff are working with DCF and the Region's Legal and Finance

departments on a "Gift Agreement" between the Region and DCF and developing fund criteria and a governance model for the disbursement of funds. The Durham Adaptive Sport Collective (DASC) will review fund applications and recommend disbursements from the Fund, but final decisions will be made by DCF's Board of Directors. Examples of initiatives that could be funded include painting boccia lines on courts in a local gymnasium and an adaptive sport and recreation information sharing and try-it event for the Grandview Kids Adolescent Transition Program. Legacy funds from other adaptive sport events and other community initiatives could also be contributed to this fund in the future so that it continues to grow.

- 5.3 An Adaptive Sport Festival will be developed in collaboration with the DASC and other partners, using its \$30,000 share of the Legacy Fund to provide school groups and the broader community with adaptive sport try-it opportunities and information about local programs. Since hosting the Games in 2019 and again in 2023, new programs and teams in adaptive sports such as Sitting Volleyball, 5-a-side/Blind Soccer, Boccia and PowerHockey (hockey played by individuals who use power wheelchairs), have launched in our community. The objective of this Adaptive Sport Festival is to foster the growth of existing programs and to identify opportunities to bring new parasport programs to the region. Funding from the 2023 Games Legacy Fund, together with the \$15,000 allocated from the 2019 Ontario Parasport Games Legacy Fund, will support implementation of the first Festival; and may enable enhancements such as creating a multi-day event or expanding the Festival.
- 5.4 The remaining \$3,579 is proposed to be directed to a partnership with Local Enhancement and Appreciation of Forests (LEAF) and the Town of Ajax to organize an event to plant more than 100 trees and shrubs in the spring of 2024. Although this initiative does not relate directly to the criteria outlined in 5.1, it aligns with broader sustainability goals of the Games. The trees and shrubs will be planted in honour of Games participants and volunteers to help offset the carbon footprint from the Games. This was a commitment communicated to Games participants and volunteers during the Games.
- 5.5 These Games Legacy Fund recommendations are supported by the MTCS.

6. Relationship to Strategic Plan

- 6.1 This report aligns with/addresses the following strategic goals and priorities in the Durham Region Strategic Plan:
 - a. Goal 2: Community Vitality

- Item 2.5 Build a healthy, inclusive, age-friendly community where everyone feels a sense of belonging.
- b. Goal 3: Economic Prosperity
 - Item 3.2 Leverage Durham's prime geography, social infrastructure and strong partnerships to foster economic growth.

7. Conclusion

- 7.1 Hosting the Durham Region 2023 Ontario Parasport Games created significant economic impact in Durham Region and has resulted in legacy funds for distribution.
- 7.2 The \$145,579 Games Legacy Fund will support the continued growth of adaptive sport opportunities, awareness and participation in Durham Region and beyond, and it is expected to enhance the lives of many individuals with disabilities living in Durham Region.

Durham Agricultural Advisory Committee

1. Backyard Chickens within Urban and Rural Settlement Areas

That as the introduction of chickens within urban and rural settlement areas (which includes towns, villages and hamlets) can result in the potential spread of Avian Influenza and other diseases to livestock in the Region, particularly poultry farms;

And that backyard chickens attract pests and predators, resulting in conflicts between predatory animals and chickens, and additional vectors for spreading disease;

Therefore be it resolved that Durham Regional Council be advised that the Durham Agricultural Advisory Committee (DAAC) does not support permitting chickens being kept in urban settlement areas and rural settlement areas (which includes towns, villages and hamlets); and

That a copy of this resolution be forwarded to the area municipalities for information.
