#### Report:

#### 1. Purpose

1.1 The purpose of this report is to provide a summary of the Durham Environment and Climate Advisory Committee's (DECAC) Pollinator Giveaway Project that took place in Spring 2024. The Project is in its third year.

#### 2. Background

2.1 The role of DECAC is to provide advice to the Region on environmental and climaterelated matters. The Committee also has a role in implementing and participating in community outreach programs and stewardship that support environmental awareness and appreciation, as outlined in the 2024 DECAC Workplan.

#### 3. Previous Reports and Decisions

3.1 In January 2024, Council considered DECAC's 2023 Annual Report, 2024 Workplan and Terms of Reference through Report #<u>2024-P-2</u>.

#### 4. Pollinator Giveaway Project

- 4.1 The Pollinator Giveaway Project is intended to raise awareness and protect pollinator health and the important role they play in supporting ecosystems, global food production and sustainability.
- 4.2 Pollinator seeds were distributed to residents attending the Durham Region Compost Giveaway events organized by the Regional Works Department. These events took place during April, May, and June in all eight municipalities across Durham.
- 4.3 DECAC members and staff from the Planning Division distributed seed packets to residents of approximately 2,200 households who attended the following events:
  - a. Town of Ajax (April 27<sup>th</sup>, 2024);
  - b. City of Oshawa (April 27<sup>th</sup>, 2024);
  - c. Township of Brock (May 11<sup>th</sup>, 2024);
  - d. City of Pickering (May 25<sup>th</sup>, 2024);
  - e. Municipality of Clarington (May 25<sup>th</sup>, 2023);
  - f. Town of Whitby (June 1<sup>st</sup>, 2024);
  - g. Township of Uxbridge (June 1<sup>st</sup>, 2024); and
  - h. Township of Scugog (June 8<sup>th</sup>, 2024).
- 4.4 The seed packets included a wildflower mix of annual and perennial native, pollenproducing plant species that are attractive to bees. Bulk seeds were obtained from a local Ontario seed supplier and assembled into individual packets by DECAC members, staff, and volunteers.

#### 5. Relationship to Strategic Plan

- 5.1 This report aligns with/addresses the following strategic goals and priorities in the Durham Region Strategic Plan:
  - a. Goal 1: Environmental Sustainability's objective: To protect the environment for the future by demonstrating leadership in sustainability and addressing climate change.

#### 6. Conclusion

6.1 Following a positive response from residents attending events in 2022 and 2023, DECAC was pleased to proceed once again in 2024. Many residents expressed excitement in receiving seeds and learning about the importance of pollinators.

Some who received seeds in previous years provided positive feedback on their quality and effectiveness in attracting pollinator populations.

- 6.2 Nearly 2,200 of the approximately 3,939 households attending the Regional Compost Day events across the Region in 2024 received pollinator seeds. Given the success of this project, DECAC looks forward to continuing the initiative again in 2025.
- 6.3 DECAC members Jay Cuthbertson, Kim Murray, Luke Nguyen, and Councillor Wilma Wotten as well as regional staff and volunteers are to be commended for the time and commitment they invested in organizing the project, assembling seed packets, and attending events to distribute seeds to residents.

Boards of health are required to "superintend, provide or ensure the provision of the health programs and services required by the [Health Protection and Promotion] Act and the regulations to the persons who reside in the health unit served by the board" (section 4, clause a, HPPA). In addition, medical officers of health are required to "[report] directly to the board of health on issues relating to public health concerns and to public health programs and services under this or any other Act" (sub-section 67.(1), HPPA).

Accordingly, the Health Information Update is a component of the Health Department's 'Accountability Framework', which also may include program and other reports, Health Plans, Quality Enhancement Plans, Durham Health Check-Ups, business plans and budgets; provincial performance indicators and targets, monitoring, compliance audits and assessments; RDPS certification; and accreditation by Accreditation Canada.

We need your help to protect not only non-native (exotic) wild animals being held in unsuitable facilities and private ownership, but also your residents. We are encouraging the Ontario government to restrict the possession, breeding, and use of non-native ("exotic") wild animals and license zoos to support municipalities and guarantee the fair and consistent application of policy for the safety of Ontario's citizens and the captive wild animal population.

Ontario is the only province that does not licence or control the keeping of non-native ("exotic") wild animals. Anyone can keep a tiger, lion, venomous snake or other dangerous animals in their home or start a zoo without professional training, adequate financing, or appropriate facilities. Unfortunately, we have seen firsthand some of these very troubling unsafe, unsanitary, and dangerous situations in Ontario with animals being held in private ownership and at roadside (backyard) zoos. These circumstances were not only unsafe for the animals but posed a significant public safety threat as well.

Since 1974, your Toronto Zoo has played a critical role in saving and protecting species locally and globally and we need your support to further protect captive exotic species in Ontario for animal welfare, public health and safety and environmental reasons.

Re: Resolution to Support Increase to Infrastructure Funding

At its regular council meeting of June 5, 2024, the Council of the Township of Bonnechere Valley reviewed correspondence

This letter is to advise that Council voted in support of this correspondence with the following resolution:

### 24.094 MOVED BYTracey SandersonSECONDED BYBrent Patrick

**WHEREAS** Ontario's small rural municipalities face insurmountable challenges to fund both upfront investments and ongoing maintenance of their capital assets including roads and bridges and water wastewater and municipally owned buildings including recreational facilities and libraries; and

**WHEREAS** in 2018, the Ontario government mandated all Ontario municipalities to develop capital asset management plans with the stipulation that they be considered in the development of the annual budget; and

**WHEREAS** small rural municipalities (of 10,000 people or less) are facing monumental infrastructure deficits that cannot be adequately addressed through property tax revenue alone; and

**WHEREAS** the Ontario Government has committed \$9.1 billion to Toronto alone to assist with operating deficits and the repatriation of the Don Valley and Gardner Expressway; and

**WHEREAS** small rural Ontario cannot keep pace with the capital investments required over the next 20 years unless both the Provincial and Federal Governments come forward with new sustainable infrastructure funding; and

**WHEREAS** it is apparent that both the Federal and Ontario Governments have neglected to recognize the needs of small rural Ontario; and

**NOW THERFORE BE IT RESOLVED THAT** Bonnechere Valley call on the Ontario and Federal Government to implement sustainable infrastructure funding for small rural municipalities;

**AND THAT** small rural municipalities are not overlooked and disregarded on future applications for funding;

**AND THAT** both the Federal and Ontario Governments begin by acknowledging that there is an insurmountable debt facing small rural municipalities;

**AND THAT** both the Federal and Ontario Governments immediately commission a Working Group that includes a member of the Eastern Ontario Wardens Caucus, to develop a plan on how to deal with the impending debt dilemma;



**WHEREAS** small rural Ontario cannot keep pace with the capital investments required over the next 20 years unless both the Provincial and Federal Governments come forward with new sustainable infrastructure funding;

**WHEREAS** it is apparent that both the Federal and Ontario Governments have neglected to recognize the needs of small rural Ontario;

At its Council Meeting of February 13, 2024, the Council of the Corporation of the City of Cambridge passed the following Motion:

**WHEREAS** this council believes that the safety of our community and its protection from crime in all its forms is of utmost importance.

**WHEREAS** our taxpayer-funded judicial system exists to protect the public, who in return for their tax dollars are entitled to a system that works.

**WHEREAS** the number of charges laid for failure to comply with court orders – primarily failure to comply with the terms of a promise to appear, undertaking, recognizance, probation order, or peace bond – are steadily on the rise in the province of Ontario.

**WHEREAS** there has been a notable increase in the number of violent offences committed in the province of Ontario by individuals who are concurrently subject to release orders.

**WHEREAS** the Ontario justice system is backlogged, court systems under strain, and police and prosecutors overwhelmed by their caseloads.

**WHEREAS** we have seen a dramatic lowering of the threshold for release, resulting in violent, serious, or repeat offenders who should by rights have been reasonably detained in custody, released on supervision plans that are increasingly deficient.

**WHEREAS** the general sense among the criminal population is that breaching bail conditions will not result in much by way of consequence for the offender, as evidenced by a clear pattern province-wide of unjustifiable release, a pattern which is bound to continue given insufficient resources to conduct Crown bail reviews, surety bond estreatment hearings, and ensure the subsequent collection of surety bond funds after judgment.

**WHEREAS** a 'catch and release' system constitutes a failure of government to perform a core function of its existence, that being the protection of public safety and that this failure constitutes a clear and present danger to the public.



**WHEREAS** the current hard drug crisis has contributed to a desperate criminal element that is exacting a significant financial and emotional toll on communities across Canada including Cambridge.

**WHEREAS** our police services are being demoralized by expending precious time and resources having to manage the repeated arrests of these habitual criminal offenders within a system that limits their ability to effectively protect the public.

**AND WHEREAS** this ineffective follow-through by our judicial system unfairly erodes the public's trust in our police services, who consequently become the target of frustrated and angry residents who feel they are no longer being protected from crime.

**AND WHEREAS** the increasing erosion of public faith and trust in our judicial system ultimately brings the administration of justice in the province of Ontario into disrepute and leads to a growing feeling amongst residents that they are no longer protected by a system perceived to prioritize the rights and freedoms of the criminal over the rights and safety of themselves and their families.





**AND WHEREAS** PS3280 is a new accounting standard covering asset retirement obligations (ARO) that was approved by PSAB in March 2018;

**AND WHEREAS** the standard must be applied by all public sector entities who prepare their financial statements under PSAB, including all Canadian municipalities;

**AND WHEREAS** many small municipalities do not have accountants or engineers on staff to complete the ARO obligations and this major accounting changes will force small municipalities to hire consultants to complete this work and cause a significant financial burden to municipalities;

#### MINUTES

#### 9-1-1 MANAGEMENT BOARD

#### May 28, 2024

A regular meeting of the 9-1-1 Management Board was held in Meeting Room 1-B, Regional Municipality of Durham Headquarters, 605 Rossland Road East, Whitby, at 10:00 AM. Electronic participation was permitted for this meeting.

#### 1. Roll Call

#### 4. 9-1-1 Call Statistics

J. Wichman provided the statistics on calls transferred from January to April 2024 by Bell Canada 9-1-1. He stated that the average number of calls were just over 17,000 for the month of May. He advised that this number is lower than last year's average due to last year's cell phone issues as well as the increase in public education.

#### 5. DRPS Update re: 9-1-1 System

J. Wichman provided an overview of the following issues involving the 9-1-1 system:

- He advised of an incident where staff was provided with the incorrect address for a 9-1-1 location. He advised that this was a Bell Canada issue which was reported and rectified quickly without incident.
- He advised of an incident where calls were being made from the nursing station of a retirement residence without any information except for the phone number. He advised that they were able to obtain the address since calls were received in the past from the same number and the address was registered in the system.
- During an evacuation procedure on February 13<sup>th</sup>, the supervisor on duty realized there was issue regarding receiving 9-1-1 calls. Bell was contacted and staff were able to address the situation. Bell has changed some of their processes to avoid this from happening again. Discussion ensued with regards to whether there a process to determine when the lines are too quiet.
- On March 13<sup>th</sup> and April 6<sup>th</sup> there were issues regarding the lines at DRPS and at the CACC, which prevented calls from being received on those lines. Bell was contacted and the lines were repaired and it was confirmed that there were no missed 9-1-1 calls. Discussion ensued with regards to whether the older infrastructure can be updated after NextGen.

### 6. Update on the Modernization of the 9-1-1 Agreement with the Area Municipalities

M. Simpson advised that the final modernized 9-1-1 Agreement was sent out in February for review and execution by each of the municipalities. She advised that this is an upgrade to the original 9-1-1 Agreement to reflect today's expectations around governance and budgets and will move some of the material from the original agreement into a service agreement between the Region and DRPS. She advised that the Town of Whitby has already endorsed the Agreement and she will be following up with the other municipalities. M. Simpson also advised that Ajax/Pickering consolidated a secondary Public Safety Answering Point (PSAP) with the Oshawa site and the language regarding the responsibilities will have to be updated to reflect the current situation.

#### 7. 9-8-8 in Canada and Interactions with 9-1-1

J. Wichman advised that in October 2023, the suicide prevention hotline assigned a number of 9-8-8 to make it easier for people to call and text if they need support. Privacy is paramount for these calls so there is little information regarding location etc. when the calls are made. If the calls are transferred to 9-1-1, it is difficult to obtain the information needed to provide assistance.

J. Wichman advised that they will eventually look at integrating 9-8-8 into the 9-1-1 network so calls transferred to 9-1-1 from 9-8-8 would have the information unblocked.

Discussion ensued with regards to the entities that are providing the 9-8-8 service and whether there is an opportunity to liaise with them; whether it is beneficial for local stakeholder groups such as Lakeridge Health and Ontario Shores to understand the current technical challenges being experienced with 9-8-8; and whether there is anything Council members can do to help with awareness and expedite the 2026/2027 time frame.

#### 8. Verbal Presentation from Adnan Naeem, Solicitor, Legal Department re: Closed Meetings

A. Naeem, Solicitor, Legal Department, provided a verbal presentation with regards to the rules surrounding confidential items and closed meetings.

He stated there are certain rules under the Municipal Act which govern committees and local boards. He stated that the 9-1-1 Management Board is considered a local board of the Regional Municipality of Durham under the Municipal Act and is subject to the Region's Procedural By-law. He provided an overview of the Municipal Act as it pertains to closed meetings and the provisions for which meetings may be closed to the public. He also provided an overview of the Region's Closed Meeting Protocol, the Ontario Ombudsman Guide for closed meetings, and the process for going into a closed meeting session.

#### **Other Departments - Comments/Concerns**

At this time G. O'Blenes advised that National Public Safety Telecommunicator Week was April 14<sup>th</sup> to April 21<sup>st</sup> and is a week set aside ever year as a time to collectively express thanks and appreciation to public safety telecommunicators across the country. He stated that DRPS took several initiatives during the week to highlight communicators, educate the public and raise awareness on what they do and the complexities of their roles in 9-1-1.

a) <u>Comments/Concerns – Regional Council</u>

There were no comments.

b) <u>Comments/Concerns – Durham Police</u>

There were no comments.

c) <u>Comments/Concerns – Fire Departments</u>

There were no comments.

d) <u>Comments/Concerns – Oshawa Central Ambulance Communications Centre</u>

There were no comments.

e) <u>Comments/Concerns – Durham Finance</u>

M. Simpson advised that J. Wichman continues to navigate the Ministry's request around the NextGen 9-1-1 grant. She also advised that the Region will be accelerating their budget process this year with the hope that the property tax budget will be considered in December, allowing all departments to know the resources they have as they go into 2025.

f) <u>Comments/Concerns – Region of Durham Paramedic Services</u>

T. Cheseboro stated that May 29<sup>th</sup> is the first meeting about the Medical Priority Dispatch System (MPDS) rollout. He stated that plans for the rollout are still several months away but there are a few services in the province that have already rolled it out under the new provincial model. He stated that this will have a significant impact on the fire service with regards to the number of calls being dramatically reduced. Once the rollout is close to starting, the fire chiefs will meet and review the tiered response agreements.

#### 9. Other Business

There was no other business.

#### 10. Date of Next Meeting

Discussion ensued with regards to whether the Board should proceed with the meeting on June 25<sup>th</sup>.It was the consensus of the Board to cancel the June meeting and proceed with the September 24<sup>th</sup> meeting at 10 AM at the Regional Municipality of Durham Headquarters, 605 Rossland Road East, Whitby, in Council Chambers.
