Chair Barton congratulated Tyler Jackson for placing 8th, and Jack Stiensky for placing 18th at the 2024 Association of Ontario Road Supervisors (AORS) Provincial Safety Truck Roadeo held on September 24-25, 2024. Chair Barton advised that there were over 500 participants across the province. Chair Barton further announced that Waste Reduction Week will take place October 21-27, 2024, and that October 2024 has been declared Circular Economy Month to show our continued commitment to transitioning to a circular economy and to waste reduction in our community.

6. Delegations

6.1 <u>Peter Barber, Scugog Resident, re: Water Supply Issues in Blackstock</u>

Peter Barber, Scugog Resident, appeared before the Committee, and expressed concerns regarding water supply issues in Blackstock.

P. Barber stated that the water system in Blackstock is crumbling and that there have been numerous watermain breaks, and as a result, staff have had to turn the water pressure down to 1 pound above the minimum provincial scale. P. Barber further stated that because the well on Highway 57 was decommissioned, everything now comes from the North end. P. Barber added that according to the Regional website, the reservoir holds roughly 34,700 litres (8,000 gallons) and with the three recent fires in town, the fire department ran out of water in 4 minutes.

P. Barber further stated that the average pumping truck pumps approximately 1500 – 2000 gallons per minute and Scugog Fire Chief Bernie stated that the fire hydrants are only meant for small fires, which is concerning.

Staff advised that they would provide an update to P. Barber along with Mayor Wotten and Councillor McDougall regarding the maintenance and status of the water system in Blackstock

Staff responded to questions from the Committee regarding what would be involved in increasing the sampling system testing to more than 2 per year; and who oversees the monitoring and collection of the AMESA data.

Staff advised that that all reports are sent to the Ministry of the Environment, Conservation and Parks (MECP) and that there have been no concerns with the results. Staff rely on internal and external expertise and are confident that the MECP is accountable as a regulatory body, and that waste management through the DYEC facility is better than the alternative which is landfills.

In response to a question from the Committee regarding the concern from the delegate that there more reports available to the public at one time that are no longer being posted now, R. Jagannathan advised that he will review with staff.

A) That the Lease Agreement with Ivanhoe Cambridge II Inc. and 7503067 Canada Inc. (collectively, the "Landlord") for premises located at 419 King Street West, Suite 180, in the City of Oshawa, containing approximately 2,539 square feet be renewed with the following terms and conditions:

- i) The renewal term is for a period of five (5) years commencing November 1, 2024, and ending on October 31, 2029;
- ii) The annual rent for years 1 through 4 of the lease term will be \$36,815.50*, payable in equal monthly instalments of \$3,067.96*, based on a rate of \$14.50* per square foot per annum and \$37,450.25* per annum in year 5, payable in equal monthly instalments of \$3,120.85*, based on a rate of \$14.75* per square foot per annum;
- iii) Additional rent for the term is estimated at \$27,573.54* per annum based on a rate of \$10.86* per square foot payable in equal monthly instalments of \$2,297.80* to cover operating costs for the premises, including common area maintenance, utilities, taxes and janitorial services. The amount per square foot for additional rent is to be adjusted annually based on actual costs;
- iv) The Region will have the option to renew the Lease for one additional term of five (5) years under the same terms and conditions, with rent to be negotiated at the time of renewal;
- v) The Landlord will be responsible for the maintenance, repairs and replacement of the systems, facilities, and equipment necessary to operate the building, the parking lot, and other common areas; and
- B) That the Regional Chair and Clerk be authorized to execute all documents associated with the Lease renewal.
