Government Relations 2024 Update and 2025 Priorities

Recommendation:

That the Committee of the Whole recommends to Regional Council:

That this report be received for information.

Report:

1. Purpose

1.1 The purpose of this report is to provide an overview to Council on 2024 government relations accomplishments and the 2025 government relations priority advocacy files as well as planned key advocacy activities.

2. Background

- 2.1 Durham Region's government relations efforts focus on fostering connections and relationships to enhance partnership opportunities with other levels of government. Regional concerns are highlighted, and advocacy for funding, policy adjustments, and support from senior government levels is pursued to further Durham's priorities, while collaborating with our local area municipalities.
- 2.2 The identification of advocacy priorities is guided by the Strategic Plan, Regional Council direction, emerging issues, and funding opportunities.
- 2.3 The execution of government relations activities is managed by two dedicated staff and is coordinated between the Regional Chair, members of Council, the CAO, and senior staff.

- 2.4 Government relations activities are strengthened through joint advocacy efforts on broader issues via staff and Regional elected official participation in associations and networks such as the Association of Municipalities of Ontario (AMO), Mayors and Regional Chairs of Ontario (MARCO), the Federation of Canadian Municipalities (FCM), Regional and Single Tier CAOs, the Greater Toronto and Hamilton Area Mayors and Chairs, the Ontario Municipal Social Services Association (OMSSA), and others.
- 2.5 Intergovernmental engagement includes meetings, letters, and formal feedback (e.g., pre-budget submissions, Environmental Registry of Ontario submissions, consultations, Standing Committee submissions).
- 2.6 Regional Council is updated on key government relations activities through the CAO's monthly briefing note update and through periodic Council reports.
- 2.7 On an annual basis, planned actions to support key objectives of the government relations priorities are identified and tracked. At the end of the year, the outputs and outcomes are analyzed and used to plan for the following year.

3. Previous Reports and Decisions

- 3.1 In December 2024, <u>a presentation to Council</u> highlighted 2024 government relations activities.
- 3.2 An annual report on government relations priorities for 2024 was provided in Report <u>#2024-COW-8</u>.

4. Highlights of 2024 Government Relations Actions and Outcomes

- 4.1 In 2024, the Government Relations team worked on 28 different issues and made significant progress on several key priorities. The highlights of the actions taken and the outcomes achieved are outlined in Attachment #1.
- 4.2 The Regional Chair, Regional Councillors and Regional staff met with MPPs, Ministers and their staff on 29 occasions including five AMO delegations and participation in pre-budget consultations. This compares to 18 times in the 2023 and exceeds the target that was set to meet government relations objectives.
- 4.3 Formal engagement was augmented by lobby interactions led by Strategy Corp and many information discussions at meetings, announcements, and events.
- 4.4 In 2024, Strategy Corp priorities were the advancement of Durham Region's GO Lakeshore East Station strategy and homelessness, mental health and addictions supports. In addition to these core priorities, Strategy Corp provided engagement and advocacy services on other emerging issues as requested.
- 4.5 A notable area of improvement in 2024 was the adoption of a more sophisticated approach to government relations meetings. It was ensured that all participants,

including staff, political staffers, and elected officials were fully briefed on the meetings objectives beforehand. This comprehensive approach, made possible with a two-person dedicated team, fosters consensus-building and has led to more productive discussions and improved outcomes.

- 4.6 The government's relations team supports department's work on key grant applications through advocacy to promote successful grant applications. Additionally, in 2024 the government relations team provided coordination support on five strategic cross-departmental grant applications related to housing, homelessness, mental health and addictions.
- 4.7 In 2024, the Region achieved significant funding success including:
 - a. \$34.9 million, the maximum funding available, under the provincial Housing Enabling Water Systems fund, for the renovation of the Oshawa Water Supply Plant.
 - b. \$6.4 million in capital funding from the federal Unsheltered Homelessness and Encampment Initiative for Phase 2 of 1635 Dundas Street East.
 - c. Frequent Builder Status from Canadian Mortgage and Housing Corporation (CMHC) which includes up to \$330 million ear-marked for Regional housing projects contingent upon successful application(s).
 - d. \$16.6 million from the province for the both the temporary and permanent bridge structures of the Beaver River Bridge.
 - e. A 9 per cent increase to land ambulance funding.

5. Government Relations 2025

- 5.1 Government relations priorities for 2025 are informed by ongoing priorities from 2024 and anticipated opportunities and challenges.
- 5.2 Priorities will continue to evolve in response to emerging opportunities and challenges including potential revised mandates from federal and provincial governments.
- 5.3 Given anticipated elections in 2025 at both the provincial and federal level, the Region's advocacy will leverage pre-election periods and deploy post-election strategies to ensure new Ministers and any newly elected MP and MPPs are aware of the Region's top priorities.
- 5.4 Specific activities anticipated for 2025 include a Queen's Park Advocacy Day with the Chair and relevant mayors, targeted joint advocacy with Regional Chairs, postelection meetings with key Ministers and alignment with MARCO and AMO on sector-wide issues.
- 5.5 In 2025, the Region is continuing with the services of Strategy Corp to advance key priorities. Strategy Corp's main priorities will include GO Lakeshore East Station strategy, homelessness, mental health and addictions supports including

securing operating funding for 1635 Dundas Phase 2. Another key focus will be assisting with the development and deployment of pre- and post-elections strategies.

- 5.6 Attachment 2 outlines the current top four advocacy files that will be priorities for advancement in 2025 as follows:
 - a. Increasing support for homelessness, mental health and addictions
 - b. Securing operating and capital funding for 1635 Dundas Phase 2
 - c. Advancing the GO Lakeshore East Extension to Bowmanville
 - d. Advancing long-term financial sustainability including adequate capital investment for growth
 - e. Investments in community housing and transitional housing renewal
- 5.7 In addition to top priority files, work will be done in 2025 to advance the following desired key outcomes:
 - a. Increased community paramedicine funding and sustainable Primary Care Outreach Program (PCOP) funding
 - b. Establishment of an urgent care mental health unit in Durham
 - c. Provincial action on increasing access to family doctors in Durham
 - d. Advancement of the Durham Scarborough Bus Rapid Transit project
 - e. A comprehensive federal approach to support refugees and asylum seekers
 - f. Funding for community safety and well-being initiatives
 - g. Addressing the rising costs of policing
 - h. Senior government clean energy investments in Durham Region
 - i. Investments in transit including fleet electrification and service expansion
 - j. The removal of tolls on provincial-owned portion of Highway 407
 - k. Reform to the bail system

6. Relationship to Strategic Plan

- 6.1 This report aligns with/addresses the following strategic goals and priorities in the Durham Region Strategic Plan:
 - a. Goal 5: Service Excellence. Objective: To provide exceptional value to Durham taxpayers through responsive, effective, and fiscally sustainable service delivery.
 - 5.1 Optimize resources and partnerships to deliver exceptional quality services and value.
 - 5.3 Demonstrate commitment to continuous quality improvement and communicating results.

7. Conclusion

- 7.1 In 2024, many key government relations files were advanced with positive funding impacts and improving the well-being of residents.
- 7.2 2025 priorities reflect a continuation of key priorities from 2024 including the GO Lakeshore East extension station strategy, supports for homelessness, mental health and addictions and improving financial sustainability.
- 7.3 Priorities and tactics in 2025 will likely be impacted by anticipated elections at the provincial and federal levels of government. Post-election strategies will be deployed to position the Region for success in advancing desired government relations outcomes.
